LIMITED LIFETIME WARRANTY
Non-prorated and transferable

Minnkota Windows warrants to the original purchaser of the Minnkota Windows vinyl window or patio door that the main frame will be free from defects in material and workmanship for as long as you own and reside in the home in which the windows or patio doors were installed. Warranty is transferable one time only. Warranty Registration and Transfer Certificate to 2nd Property owner must be on file with Minnkota Windows.

BASIC WINDOW UNIT LIFETIME WARRANTY

The rigid vinyl in the window is warranted against chipping, cracking, peeling or blistering, for as long as you own and reside in the dwelling in which these windows were installed. This limited warranty does not apply to improper installation, any damage caused by improper handling or storage, flood, explosion, misuse, abuse, vandalism, use of harmful chemicals, unapproved coatings, or other external forces. All warranty work includes replacement parts and labor.¹

COLOR

Atmospheric pollution and residues deposited on the window can discolor it. Mild soaps or detergents are usually all that are necessary to restore the color. Paint coatings applied by others and not approved by Minnkota Windows will not be covered under this warranty.

EXTERIOR COATING

The specialized exterior coating applied by Minnkota Windows is guaranteed under normal conditions for a period of fifteen (15) years from the initial date of application, against weathering, specifically, "peeling, cracking or blistering from/on the applied surface and significant ultraviolet discoloration" (greater than 6 Delta E units) caused by natural environmental atmospheric conditions. Full coating manufacturer's warranty will apply.

INSULATED GLASS UNIT LIFETIME WARRANTY

The sealed insulated glass unit is warranted against defects resulting in material obstruction of vision from film formation caused by dust or moisture in the dead air space of the sealed unit for as long as you own and reside in the home in which the windows or patio doors were installed.¹ This warranty does not apply to any exterior damage or scratches found after the windows have been delivered or installed. Blinds Between the Glass covered by separate ten (10) year manufacturer's warranty with labor included.

ACCIDENTAL GLASS BREAKAGE

If a panel of insulated glass should break during the glass warranty period, a replacement shall be furnished at no charge. The furnishing of a replacement insulated glass panel does not cover or include any labor costs incurred in the removal or reinstallation of the insulated glass panel or window. Shipping and handling are not covered. Architectural shapes (bent

shapes), special shaped windows and patterned or decorative glass windows are excluded. This does not cover damages that result from misuse or neglect, vandalism, fire, flood, earthquake, lightning, ice, hail, windstorms, tornadoes or other acts of God or acts of civil unrest (war, riots). This is limited to the original single family homeowner and is transferable one time. It is not applicable for products installed in commercial or multi-family dwellings.

CONDENSATION

Condensation of any window occurs when warm, moist air comes in contact with the cooler surface of a window. Condensation does not indicate a defective or faulty window and is not covered under this warranty. Additional information is available upon request.

LABOR

Labor and freight will be included for a period of twenty (20) years for all insulated glass warranty work in any Minnkota Windows product.¹

THE SOLE AND EXCLUSIVE REMEDY FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY OF THIS PRODUCT IS REPAIR OR REPLACEMENT OF THE PRODUCT AT MINNKOTA WINDOWS DISCRETION. WARRANTOR SHALL NOT BE LIABLE UNDER ANY CIRCUMSTANCES FOR ANY INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES, TO THE EXTENT THAT SUCH LIABILITY MAY BE EXCLUDED UNDER APPLICABLE LAW. Some states do not allow the exclusion of limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. No person, including any agent, employee or representative of the Warrantor has any authority to bind Warrantor to any affirmation, representation, or warranty concerning this product, except as stated in this warranty. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

In order for this warranty to be valid, Warranty Registration card must be completed and returned to Minnkota Windows, or registered online at the Minnkota Windows website, within ninety (90) days of receipt of product. If not returned within ninety (90) days, warranty will be void.

Any warranty claims shall be submitted through an authorized Minnkota Windows dealer.

¹Applications other than for single family residential homes are warranted for a period of ten (10) years for materials only. Labor and shipping costs are not included in this commercial warranty.
